The staff includes approximately 780 permanent positions out of which about 80 devoted almost exclusively to research. The overall yearly budget was in the range of 60 million euros and the research budget was approximately 4.5 million euros. The Institute hosts since 1992 the WHO Collaborating Centre for Maternal and Child Health, which was promoted and led from its establishment until January 2004.
